checking in WITH CAREGIVERS

Caregivers were strongly in favor of seeing the TiCCA continue and encouraged expansion of its use in other counties

Information educates caregivers about child needs

Early assessment clarifies what struggles were pre -existing before foster care

Trauma -informed parent training was highly praised by foster parents, and considered an extremely valuable addition

TiCCA findings can be difficult to hear

Reasons for administering the TiCCA may not be adequately explained to all caregivers
