

Hi Scott -

I have looked at some of your website pages. I'm writing to ask you what would be the best source of information about the reliability and validity characteristics of the Outcome Rating Scale? I have other questions, also:

- Can you point me to information about the scale's use with children and adolescents across settings, such as outpatient therapy (individual, family, group), Partial Hospital Program, Acute Inpatient Unit, outpatient medication management?
- When does the client complete the scale? Before, during, after a session?
- For children and adolescents, do you obtain ratings from the child/adolescent and parent(s)?

I work at a private, not-for-profit children's psychiatric hospital. Our behavioral healthcare programs will become subject to a new measurement standard from the Joint Commission effective January 1, 2018. I have attached a copy of the text of the standard. Our current measurement system is not robust enough to meet this standard. So, I would like to learn more about ORS and FIT and potential for our use among others we will consider.

By the way, the Joint Commission is currently providing a list of potential measures for use by accredited organizations to meet this standard. If you are interested, you can have information about ORS posted
